General Information

The United Electric irrigation program has been developed to encourage energy-efficient equipment and design in irrigation systems. It is an opportunity for irrigation members to receive a financial rebate and lower their electric bills. Through this program, you may qualify to receive a rebate for a portion of the cost to install a new, more efficient system, or to make energy-efficient improvements to an existing system. This program helps you pay for energy-efficiency features in your irrigation system, and encourages you to use electricity in an economically efficient manner.

Deemed measures rebates are designed to help cover a significant portion of the costs in repairing and replacing specific components that typically help the irrigation system use less energy. Rebates are for the purchase of specified replacement parts and components for your existing irrigation system, and must be submitted with itemized invoices.

To participate; replace or repair specific components (designated in the application), submit required paperwork, and receive the rebate shown. The rebate varies by the sprinkler component or part incorporated in your sprinkler system.

The rebate may not exceed the amount for the invoice provided.

Rebate Application Process

Review sprinkler components covered to determine which apply to your system.

Determine the quantity needed to replace existing and worn sprinkler parts on your system.

Purchase and install components/parts on your irrigation system.

Complete this application and return to United Electric along with sales receipt/invoice.

Terms & Conditions:

This system is used for irrigation of agriculture crops or pasturage.

The designated sprinkler parts have been purchased for the sprinkler system at the specified metered service location.

An itemized receipt or invoice identifying the new equipment purchased accompanies the incentive application.

Utility rebate amounts are subject to change and are only available while funds are available.
